Why don't cases get solved? Unsolved crimes, unsuccessful prosecutions, unpunished offenders and wrongful convictions bring the criminal justice system into disrepute. Criminal investigative failures have serious consequences, but are rarely studied, and therefore their causes are not commonly understood. Mr. McCrary will tackle the question of "Why cases don't get solved?".
