### 11:15 Application of U.S. IP Law to Exports, Offshore, on the Outer-Continental Shelf, the High Seas, and Overseas (.75 hr)

The presenters will explain how U.S. law applies within the 12 mile limit, on the seabed floor on the outer-continental shelf, on U.S. flagged vessels on the high-seas, as well as explore when U.S. law applies overseas. The presenters will discuss Section 271(f)'s application to exports, and the predicate act doctrine in copyright law. The presenters will also discuss how intentional torts abroad can be remedied in U.S. IP cases, as with inducement abroad of infringement within the U.S. and trade secrets licensed here but stolen in another country.

### 2:45 Considerations in Joint Development Agreements for Energy Technologies (.75 hr)

The dual nature of energy companies as both commercial players in a competitive market and developers of cutting-edge technologies presents a number of challenges for intellectual property attorneys negotiating and drafting joint development agreements that protect various participants' interests in the developed technologies. This talk will address issues that may impact energy companies' interests with regard to these agreements, including: ownership, prosecution, exploitation, and enforcement of jointly developed IP; protection of confidential information and background IP; joint ventures for technology development; and issues to consider when developing technology with universities or start-ups.

### 3:30 The EU General Data Protection Regulation in Energy Practice (.75 hr)

As energy becomes a more data-driven field, technology design, contractual terms, and internal governance become increasingly subject to privacy, data protection, and cybersecurity considerations. The EU General Data Protection Regulation (“GDPR”) enters into force on May 25, 2018, creating a unique globally-reaching sanctions regime for companies that collect and process certain personal data. In parallel, EU Member States are creating statutes defining IT and energy as critical infrastructure subject to heightened cybersecurity requirements. This presentation will introduce key points of the GDPR likely to be of interest to energy companies and practitioners, including the scope of GDPR-affected data, risk allocation in contract drafting, questions on machine-to-machine data regulation, vendor/supplier compliance, cybersecurity practices, and an outlook on the European enforcement and litigation landscape.
